I understand that to vote in this town, I must be 18 years of age, I must be a United States citizen, and I must be domiciled in this town.</p> <p>I understand that a person can claim only one state and one city/town as his or her domicile at a time. A domicile is that place, to which upon temporary absence, a person has the intention of returning. By registering or voting today, I am acknowledging that I am not domiciled in any other state or any other city/town.
